This is a reissue of an Ad Alert first published in 2021 and updated in 2023.

The CAP Compliance team remains concerned about the continued appearance of problem ads for products from Health Broadcast, including Copper Insoles and Detox Footpads.

The ASA have previously upheld complaints about ads which claim that orthotics can treat various conditions, where evidence was either lacking, or was not sufficiently robust.

Marketers have tried in the past to establish that the human body accumulates toxins that can be purged. CAP and the ASA understand that the body's liver and kidneys automatically detoxify and excrete many toxin materials, including metabolic wastes, and has not seen evidence to support the theory that toxins can be removed from the body by other means.

CAP have advised Health Broadcast to make use of our Copy Advice service prior to publication of ads.

**CAP is concerned at the advertiser's continued non-compliance and asks the national/regional press to contact the CAP Copy Advice team before accepting any ads from Health Broadcast.**
